Conditions of the admissions procedure

The programme opens on-site and combined (part-time) formats in Czech and English language, with the standard period of study being 4 years. Upon successful completion of the programme, the graduate will receive the title of Ph.D. Admission of up to 10 applicants to each language modification of the programme is expected.

I. Applications

Requirements for acceptance to the admissions procedure, no later than the **30st of August 2021:**

(1) Submit an electronic application in the university information system STAG, which is accessible here:

https://portal.ujep.cz/portal/studium/uchazec/eprihlaska.html?pc_lang=en

(2) Pay the fee of CZK 500 for actions connected with the admissions procedure according to the instructions when submitting the application. The applicants for the programme in English language are liberated from the payment.

(3) Provide an officially certified copy of your diploma proving the proper completion of a Master's study program (it is possible to bring it in person or to send it by post to the address of the study department to Bc. Lenka Petláková). Applicants who have obtained a university degree at a foreign university will prove the achievement of the required university education in the manner specified at https://www.ujep.cz/cs/nostrifikace.

(4) Send the following two documents **in English** in pdf format to the address of Lenka Petláková (<u>lenka.petlakova@ujep.cz</u>)

i. **curriculum vitae**, including any creative work and publications (preferably with reference to their electronic format);

ii. **doctoral project (expose) -** a text in the length of 3-5 pages, which with references to current international scientific literature, clearly defines:

- a) the research problem,
- b) the research goal,
- c) the research methodology.

For the doctoral project (expose) of the candidates following topics are suggested ZDE. In case the candidate prefers own topic, the project should also include the name of the proposed future project supervisor and advisor respectively.

The link on regbes.eu will be added.

II. Conditions of Acceptance

Applicants will be accepted on the basis of the admissions commission's recommendation, which is based on the evaluation of the curriculum vitae, the doctoral project (expose) and the interview via MsTeams.

The quality of the doctoral project (expose) and the curriculum vitae will be evaluated on a scale of 0-10 points from each member of the admissions commission.

The interview will be evaluated on a scale of 0-10 points from each member of the admission commission.

For an applicant to be admitted to the study program, it is necessary to receive a minimum of 10 points from each member of the admissions commission for both parts of the admission procedure.

In the case of a higher number of applicants, the ranking of candidates drawn up by the admissions commission shall be decided on the basis of the above criteria.

The interview via MsTeams platform is scheduled for 14th September 2021.

Applicants will be informed about the results of the admissions procedure by the **21**st **September 2021.**

The date of enrolment into the study program for successfull applicants in online form is **24**th **September 2021.** The details will be provided in the admission decision.
