#### **Conditions of the admissions procedure**

The programme opens on-site and combined (part-time) formats in Czech and English language, with the standard period of study being 4 years. Upon successful completion of the programme, the graduate will receive the title of Ph.D. Admission of up to 10 applicants to each language modification of the programme is expected.

#### **I. Applications**

Requirements for acceptance to the admissions procedure, no later than the **31st of August 2022**:

(1) Submit an electronic application in the university information system STAG, which is accessible here:

<https://portal.ujep.cz/portal/studium/>

(2) Pay the fee of CZK 500 for actions connected with the admissions procedure according to the instructions when submitting the application. The applicants for the programme in English language are liberated from the payment.

(3) Provide an officially certified copy of your diploma proving the proper completion of a Master's study program (it is possible to bring it in person or to send it by post to the address of the study department to Bc. Lenka Petláková). Applicants who have obtained a university degree at a foreign university will prove the achievement of the required university education in the manner specified at <https://www.ujep.cz/cs/nostifikace>.

(4) Send the following two documents **in English** in pdf format to the address of [jirina.jilkova@ujep.cz](mailto:jirina.jilkova@ujep.cz), in the copy to Lenka Petláková ([lenka.petlakova@ujep.cz](mailto:lenka.petlakova@ujep.cz)):

i. **curriculum vitae**, including any creative work and publications (preferably with reference to their electronic format);

ii. **doctoral project (expose)** - a text in the length of 3-5 pages, which with references to current international scientific literature, clearly defines:

- a) the research problem,
- b) the research goal,
- c) the research methodology.

For the doctoral project (expose) of the candidates specific topics are suggested.

## II. Conditions of Acceptance

Applicants will be accepted on the basis of the admissions commission's recommendation, which is based on the evaluation of the curriculum vitae, the doctoral project (expose) and the interview via MsTeams or in-person format.

In the case of a higher number of applicants, the ranking of candidates drawn up by the admissions commission shall be decided on the basis of the above criteria.

The interview via MsTeams platform is scheduled for **14<sup>th</sup> or 16<sup>th</sup> September 2022**.

Applicants will be informed about the results of the admissions procedure by the **21<sup>st</sup> September 2022**.

The date of enrolment into the study program for successful applicants in online form is **24<sup>th</sup> September 2022**. The details will be provided in the admission decision.
