#### **Conditions of the admissions procedure**

The program opens on-site and combined (part-time) formats in the Czech and English languages, with the standard study period being four years. Upon successful completion of the program, the graduate will receive the title of Ph.D. Up to 5 applicants to each format of the study program will be accepted for their studies.

#### **I. Applications**

Requirements for acceptance to the admissions procedure, no later than the **31st of August 2024**:

(1) Submit an electronic application in the university information system STAG, which is accessible here:

<https://portal.ujep.cz/portal/studium/>

(2) Pay the fee of CZK 0 for actions connected with the admissions procedure according to the instructions when applying.

(3) Provide an officially certified copy of your diploma proving the proper completion of a Master's study program (it is possible to bring it in person or to send it by post to the address

of the Faculty to Mgr. Barbora Kamarýtová). Applicants who have obtained a university degree at a foreign university will prove the achievement of the required university education in the manner specified at <https://www.ujep.cz/cs/nostifikace>.

(4) Send the following two documents **in English** in pdf format to the address of [lenka.slavikova@ujep.cz](mailto:lenka.slavikova@ujep.cz) in the copy to [barbora.kamarytova@ujep.cz](mailto:barbora.kamarytova@ujep.cz):

- i. **curriculum vitae**, that includes any creative work and publications (preferably concerning their electronic format);
- ii. **doctoral project (expose)** - a text (3-5 pages long) with references to current international scientific literature that clearly defines:
  - a) the research problem,
  - b) the research goal,
  - c) the research methodology.

Specific topics for the doctoral project (expose) of the candidates are suggested.

## II. Conditions of Acceptance

The acceptance of applicants is based on the Admission Committee's recommendation, which combines the evaluation of the: a) curriculum vitae and the doctoral project (expose) and b) **the interview in english** via online or in-person format.

The quality of the doctoral project (expose) and CV will be evaluated on a scale of 0 - 10 points by each Admission Committee member (obligation to obtain at least 5 points).

The interview will be evaluated on a scale of 0-10 points by each member of the Admission Committee (obligation to obtain at least 5 points).

To be admitted to the study program, it is necessary to achieve a minimum of 10 points from all members of the Admission Committee in the sum of the points gained from both parts of the admissions procedure.

For more applicants, the ranking of candidates drawn up by the Admission Commission shall be decided based on the above criteria.

The personal interview in english will be held on **9<sup>th</sup>September 2024**. The appointment will be specified in the invitation.

Applicants will be informed about the results of the admissions procedure by the **13<sup>th</sup> September 2024**.

The date of enrolment into the study program for successful applicants will take place in person in the faculty building from **16<sup>th</sup>September 2024 to 30<sup>th</sup>September 2024**. The specific date of enrollment will be specified in the invitation to enrolment, which the applicant will receive after the decision on admission to study has been issued. The details will be provided in the admission decision.

## III. Tuition fee

Tuition fees for a study program in English for one academic year are governed by the current Rector's directive No.1/2023 Fees at UJEP (check it here: <https://1url.cz/Hr83Q>)
